### BY-LAW 411 A BY-LAW RELATING TO THE COMPOSITION OF THE OROMOCTO TOWN COUNCIL

The Council of the Town of Oromocto under the authority invested in it by Section 29 of the <u>Municipalities Act</u> enacts as follows:

- 1. The elected Council for the Town of Oromocto shall consist of a Mayor and six Councillors.
- 2. The qualifications of candidates for the Council of the Town of Oromocto shall be as provided for in the Municipal Elections Act as to who is eligible to be a candidate for the office of Mayor or Councillor of the municipality.
- 3. The division of representatives of the elected Council of the Town of Oromocto shall be as follows:

Two (2) Councillors for each of the three (3) wards and one (1) Mayor to be elected at large.

- 4. The boundaries of the wards shall be as described in Schedule "A" and depicted in Schedule "B" annexed hereto and made a part hereof.
- 5. By-Law No. 264 "A By-Law Respecting the Composition of the Town Council" is hereby repealed.

## SCHEDULE "A"

Ward One - Commencing at the Town's Northeasterly boundary intercept with the Saint John River and proceeding Westward, following the Town boundary along the edge of the Saint John and Oromocto rivers, to the point of intercept with Route 2/7 Highway and the Oromocto River; then turning Eastwardly along Route 2/7 Highway to the point of intercept with the pedestrian underpass, then Northeasterly to D'Amours Street, then Eastwardly on D'Amours Street to its point of intercept with Route 102 Highway (Restigouche Road); turning Westward on Route 102 Highway (Restigouche Road) to the junction of Restigouche Road North and then proceeding Northerly along Restigouche Road North, exclusive of all residences there on, to the junction of Waasis Road; then turning Easterly on Waasis Road to its point of intercept with the DND boundary at Evans Drive, then following the DND boundary around Evans Drive and Oromocto First Nation to a point of intercept with Route 102 Highway (Waasis Road); then proceeding Northeasterly along Route 102 Highway (Waasis Road) to the point of intercept with the Sentier NB Trail and Easterly along the trail to the Town boundary and then Northerly along the Town boundary to the point of origin.

**Ward Two** - Commencing at the point of intercept of the Sentier NB Trail with the Route 102 (Waasis Road) and proceeding Easterly along Sentier NB Trail/Oromocto Town Boundary and following the Town boundary Easterly and then Southerly to its point of intercept with Shirley Road; Westerly along Shirley Road/Town Boundary to its intercept with Route 660 Highway (Broad Road) and then Northerly along Route 660 Highway (Broad Road) to its junction with Route 102 Highway (Restigouche Road) and Westerly along Route 102 Highway (Restigouche Road) to the junction of Restigouche Road North; then Northerly along Restigouche Road North, inclusive of all residences thereon to the junction of Waasis Road, then turning Easterly on Waasis Road to its point of intercept with the DND boundary at Evans Drive, then following the DND boundary around Evans Drive and Oromocto First Nation to a point of intercept with Route 102 Highway (Waasis Road); then proceeding Northeasterly along Route 102 Highway (Waasis Road) to the intercept of the Sentier NB Trail, being the point of origin.

**Ward Three -** All lands within Town boundaries commencing at the point of intercept of Route 2/7 Highway and the Oromocto River, Easterly along Route 2/7 Highway to a point of intercept with the pedestrian underpass, then northeasterly to D'Amours Street; then Easterly along D'Amours Street to its point of intercept with Route 102 Highway (Restigouche Road) and Easterly along Route 102 Highway (Restigouche Road) to its junction with Route 660 Highway (Broad Road); Southeasterly along Route 660 Highway (Broad Road) to its northeasterly and Westerly along the Town boundary to its intercept with the Oromocto River and then Northeasterly along the river to the point of origin.
