


BY-LAW NO 510-D

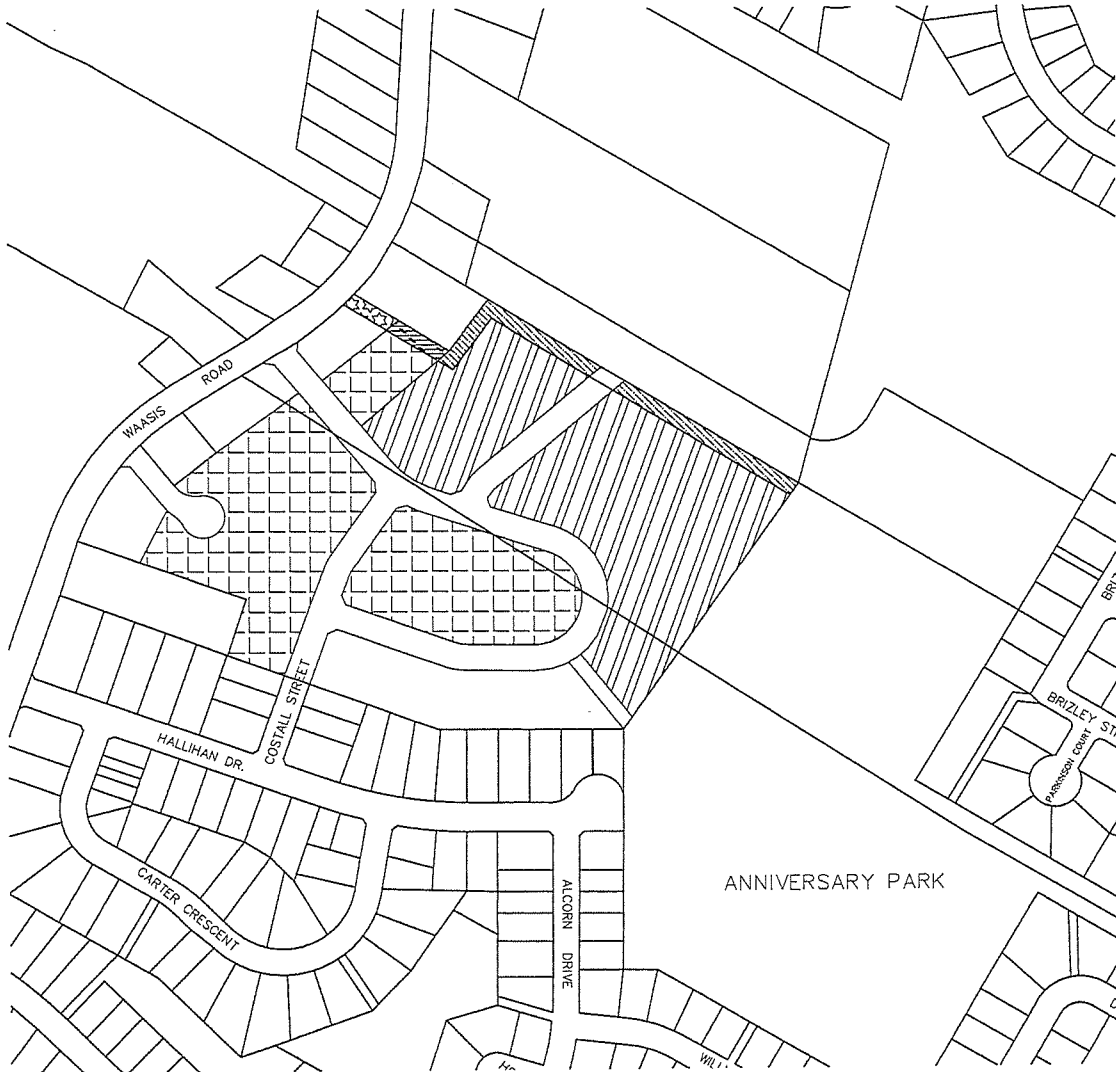
