# 7.c Oromocto and Area Health Care Recruitment Committee

The Mayor report the Oromocto and Area Health Care Recruitment Committee met on Monday, 15 September 2025, at 5:30 pm in Council Chambers. A discussion was held about the new Health Centre on Base and how the opening has been held up as the funding model has not yet been finalized and neither has the support staff been put in place. He reported that Dr. Paulin's medical clinic has added two new doctors with another one arriving very soon.

There will be a family medicine resident recruitment event happening on the 24-25 September 2025 in St. Andrews, NB and three members of the recruitment committee will be in attendance.

On 9 July 2025, the City of Fredericton and the Town of Oromocto participated in a physician recruitment activity. Oromocto entertained nine of the medical students for over five hours and provide a tour of the Oromocto Public Hospital, a boat ride on the Oromocto River and lunch.
