

BY-LAW 541
A BY-LAW RELATING TO THE FIRE DEPARTMENT LEVEL OF SERVICE IN
THE TOWN OF OROMOCTO

BE IT ENACTED by the Council of the Town of Oromocto under the authority vested in it by Section 186 of the Local Governance Act, S.N.B. 2017, c.18

1. PURPOSE AND INTENT

- 1.1. The Town of Oromocto will provide community fire, rescue, and medical first response services according to the provisions of this policy statement.

2. TITLE

- 2.1. This By-Law may be cited as the Town of Oromocto Fire Department Level of Service By-Law.

3. DEFINITIONS

- 3.1. The following definitions shall apply to this by-law:

a. **“Response Levels and Minimum Staffing”** means:

- 3.1.a.1. Awareness Level: Firefighters will recognize risks and hazards, secure the area, and call for trained assistance.
- 3.1.a.2. Operations Level: Firefighters will take defensive action to contain and control the incident and seek assistance from outside agencies equipped to mitigate the incident. Operations depend on adequate staffing levels to provide an effective response force (ERF).
- 3.1.a.3. Technician Level: Firefighters will initiate offensive action to bring the incident under control and to an end. This depends on adequate staffing levels to provide an effective response force.

b. **“Minimum staff”** refers to the minimum number required to initiate a response without mutual or automatic aid.

c. **“Orientation”** means the initial onboarding, such as Human Resources, Occupational Health and Safety, and equipping new staff with tools, equipment, apps, and personal protective equipment.

d. **“OHS 20+ Members”** refers to the minimum New Brunswick Occupational Health and Safety, WorkSafe New Brunswick requirements for worksites with 20 or more workers. A formal Occupational Health and Safety Program is required.

e. **“Fire Prevention”** includes all fire prevention services such as Public Education, Fire Inspections, and Fire Investigations.

f. **“Team Lead”** refers to the development of senior staff and Officers, leadership, safety, critical thinking and decision-making skills, administration, and record keeping.

g. **“Municipal Demand Zone(s)”** means the Town of Oromocto includes multiple demand zones for response within its borders, including urban, suburban, rural and remote demand zones.

h. **“General Firefighting”** refers to the required basic skills and training post-orientation involving personal and team safety.

i. **“Apparatus and Vehicle Operations”** refers to driver training to meet the Motor Vehicle Act: operations of vehicle systems excluding pump operations.

j. **“Fire Suppression (Exterior Operations)”** refers to training based on NFPA 1001-L1. Equivalent certification is achieved through the New Brunswick Community College.

- k. **“Fire Suppression (Interior Operations)”** refers to interior Structural Fire Suppression, including operations inside burning structures by appropriately trained personnel only.
- l. **“Wildland/Grassland Firefighting”** refers to training based on NFPA 1051 JPR’s.
- m. **“Dangerous Goods and Hazmat”** refers to the ability to identify a hazardous Hazmat event and its potential consequences, ensure public safety, secure hazardous zone(s), and perform evacuation, if necessary.
- n. **“Vehicle Firefighting”** refers to identifying and training particular techniques and practices related explicitly to Vehicle Fires.
- o. **“Traffic Control”** refers to the essential competencies in working on roadways, including providing a safe area for all responders and controlling traffic flow.
- p. **“Pumping Operations”** refers to the competencies related to operating and using fire pumps on apparatus.
- q. **“Response to Alarms”** means the response to occupancies, including monitored alarm systems, CO alarms, suspicious odours and basic knowledge of fire alarm panel functions.
- r. **“Vehicle Extrication”** refers to the safe removal of trapped or pinned occupants of motor vehicle collisions using hand, air, electric, or hydraulic-operated extrication tools.
- s. **“Technical Rescue – Ice Rescue”** means effecting rescue in frozen or partially frozen bodies of water.
- t. **“Technical Rescue – Rope Rescue”** means the rescue of victims using various rope, haul and belay systems.
- u. **“Medical Co-Response”** refers to intermediate first aid: CPR, AED, and assisting EMS with support in a medical emergency that involves intervention for immediate life-threatening medical conditions.
- v. **“Structural Firefighting (Low Rise Buildings)”** means the structural fire suppression operations of low-rise buildings.
- w. **“Large Vehicle Rescue”** refers to the rescue from transport tractors and other large vehicles.
- x. **“Wildland Urban Interface Fire Suppression”** means specialized equipment and training required per NFPA 1051.
- y. **“Technical Rescue Surface Water Rescue”** refers to effecting rescues on lakes and other static bodies of water.
- z. **“Technical Rescue – Wilderness Search and Rescue”** means the search, rescue, and recovery of individuals in wilderness environments.
- aa. **“Aerial Operations”** refers to the competencies related to the operation of aerial apparatus or ladder trucks.
- bb. **“High-rise building Firefighting”** refers to firefighting in structures more than three stories tall with the potential for high occupancy.
